In order to be eligible for a Federal Direct loan, I understand that I must:

- Complete a Loan Entrance Counseling
- Complete a Direct Loan Master Promissory Note (MPN)
- Matriculate in an eligible degree or certificate program
- Enroll for at least eight credits (half time) per session
- Attend at least half time (eight credits) until the conclusion of the session in order to remain eligible
- Maintain Satisfactory Academic Progress
- Not be in default on a previous student loan
- Not have surpassed my borrowing limits for federal loans

Students generally receive their federal student funds in two disbursements for the Academic Year.

First-time, first-year borrowers at the Columbia College cannot have loan funds disbursed until 30 days before the borrower enrolls. First-time borrowers will no longer be eligible for a Direct Subsidized Loan once the student has received the Subsidized Loan for a period that is 150% of the published length of the student's current educational program.
