# 2022-2023 V1 Dependent Standard Verification Worksheet

Your 2022–2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, Columbia College Office of Student Financial Aid (CC OSFA) may ask you to confirm the information you and your parent(s) reported on your FAFSA. To verify that you provided the correct information, CC OSFA will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and one of your parents, whose information was submitted on the FAFSA, <u>must complete and sign this worksheet</u>, <u>attach any required documents</u>, and <u>submit this form and the required documents to CC OSFA</u>. After a review of the information you submit, the CC OSFA may still ask for additional information. If you have questions about verification, contact the CC OSFA as soon as possible so that the processing of your financial aid will not be delayed.

  - A 2020 IRS tax return transcript will be summited to the CC OSFA later. The CC OSFA cannot complete the process of your financial aid until the IRS tax return transcript has been submitted to the CCOSFA.
