## 2022-2023 V4 Dependent Custom Worksheet

Your 2022–2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. If there are differences, your FAFSA information may need to be corrected. You (and your spouse, if married) whose information was submitted on the FAFSA, must complete and sign this worksheet, attach any required documents, and submit this form and the required documents to CC OSFA. After a review of the information you submit, the CC OSFA may still ask for additional information. If you have questions about verification, contact the CC OSFA as soon as possible so that the processing of your financial aid will not be delayed.
